



# **MY JOURNEY INTO MASK-ED**

Early in August, with a certain amount of trepidation, and a large slice of fear of the unknown (better known as "anxiety"), I accompanied a handful of my colleagues from Clinical Education at TQEH and joined other colleagues from Staff Development at the RAH on a two day training exercise formally known as MASK-ED.

For those of you unfamiliar with MASK-ED, also known as KRS (Knowledgeable Realistic Spontaneous) Simulation, the basic idea is to transform yourself into a character of your own creation and to then use your character's behaviour to get a certain message across in the teaching environment.

Coincidentally, KRS also stands for Kerry Reid-Searl's initials. Kerry is the innovator and educator responsible for MASK-ED, and she does an incredible job in espousing the philosophy behind MASK-ED. Following an introduction and background information, the impact of MASK-ED is demonstrated with a hefty blow. Assembling in the skills lab to await the arrival of a character, my colleagues and I were unsure to say the least. Logically, you know that the person coming through the door is Kerry in disguise, having said that, she is dressed as an old man, walking like and old man, and wearing a mask that is realistic enough to drop the jaw. Then she begins to speak, and the deception is completely overwhelming.

Within minutes you are wrestling with the fact that this elderly gentleman is obviously in need of assistance. With a shuffling gait and even simulated private parts on show, Kerry is now tapping into something very awkward but tangible. This is when you realise that in becoming the patient, as an educator, not only it is possible to dictate the content and context of the simulation, but you also have the ability to observe all student responses from the patient's point of view. Furthermore, as Kerry demonstrated, give your character a reason for being there, a history of hospital experiences, and a previous career that gives credence to the knowledge imparted, you now have a high impact learning situation.

Day one closes with the news that we now have a mission. Overnight, we must create our own characters, and the culmination of day two will involve donning of the masks and bringing our creations to life. This is not as easy as it sounds. The character must have a voice, a life story and a pertinent message to the audience, resulting in a learning experience.

I created the person I felt would get my message across, and feeling fairly confident with my creation, the time came to don the mask. I would have to say that wearing the mask is the most challenging aspect of all.

This is not simply a face mask. The one piece silicone device covers the whole head and sits across the as much as you can manage, and speaking clearly is a challenge.

As the teaching situation I have ordained to be my first MASK-ED teaching experience draws near, the trepidation and anxiety have returned. I know the message I wish to deliver, and I know my character well. He now has clothing, a story, a voice, and a reason to be there. Whether I can pull it off, and how much educational impact I will make remains to be seen.

I believe it will be powerful if I get it right. Irrespective of my results, if you have any involvement in simulation training, I strongly recommend you take a look at the work of Dr Kerry Reid-Searl.

May be conferred upon individuals.



# **TOUR OF DARWIN CONFERENCE FACILITIES**

Last August I undertook on behalf of ANTS an assessment tour organised by the Darwin Convention Centre and the Northern Territory (NT) Convention Bureau. The aim of this tour was to showcase to invited representatives of various professional and business associations, as well as some conference organisers, the merits of Darwin as a future conference venue. Some 18 individuals drawn from a wide range of professional and industry groups participated in a four day long inspection of conference, accommodation and associated cultural/tourist sites around the Northern Territory's capital. This report gives for ANTS members a summary of my findings and some thoughts on the future direction of our national conferences post Adelaide 2014 inspired by what I heard and saw during this trip.

The tour was exceptionally well planned and managed by officers of the Darwin Convention Centre and the NT Convention Bureau, but it was also quite intense and very much a fact finding business trip. I began the tour with a degree of scepticism. I had last visited Darwin in 1987 when it was still very much a frontier town and I had doubts about the feasibility of holding a conference in such a remote and climatically demanding spot. I found much had changed; Darwin is currently experiencing a boom, the city now has a population of around 130,000, there are multistorey buildings scattered across the urban area, numerous shops and eateries, modern cultural institutions and the Darwin foreshore, once the haunt of swamps, sand and the odd derelict, is now being extensively developed and landscaped.

Most importantly from the ANTS perspective the conference facilities are excellent. The Darwin Convention Centre located in the harbour foreshore redevelopment is architecturally eye catching, very modern in design, large with three levels that can be adapted to varying sizes and functions, excellent catering and enjoys an impressive vista across the harbour and the city. There is good hotel/apartment style accommodation within walking distance. The Hilton Hotel chain has recently arrived and is now upgrading its building in the CBD to five star level and there are several other hotels of an acceptable standard. Darwin is not a large city and travelling between the CBD and the Convention Centre is short and easy. Darwin Airport is about to be upgraded and will be significantly bigger by late 2014. I had the impression that the Convention Centre management is keen to attract business and is well organised and obliging. Likewise for the staff of the NT Convention Bureau.

The various presentations and tours of inspection suggested to me that there are distinct possibilities of ANTS being able to collaborate with several bodies including the Charles Darwin University and the Royal

Darwin Hospital. The University has excellent meeting facilities and wants to promote links with outside professional groups. We had a fascinating, if slightly morbid, presentation by Dr Notaras, Executive Director of the National Critical Care and Trauma Response Centre, on the role of Royal Darwin and the National Trauma Response Centre in such incidents as the Bali Bombings and Disaster Response.

Equally valuable was the opportunity to compare notes with the executive officers of other professional associations in the organising of national conferences. What became clear in our discussions is that most professional groups are now completely outsourcing the management of their national conferences to professional convention organisers, except for the selection of speakers and determining the program content. While this does entail higher costs for associations the consensus in our conversations is this is now the only viable means of running national conferences. All the spade work and most of the labour involved with venues, hotels, caterers, airlines, publicity, publications, websites, reservations etc. is undertaken by third parties. This view accords with my own experiences in arranging conferences. Mounting conferences at any level is onerous, mounting national conferences is extremely demanding of time, energy and commitment. I am sufficiently antique to recall working on conference committees in the 1980s when there would be enthusiastic groups of volunteers who freely gave their time to plan and run international conferences, often with the support of their employing institutions. That is a past era. Today health professionals contend with time consuming jobs, heavy work responsibilities and serious budgetary issues. Our institutions are, by and large, far less supportive of such 'extra-curricular', activities and most health professionals are now feel themselves to be time poor and under pressure.

If professional associations like ANTS wish to continue to have national conferences, and these are usually seen as a major benefit of membership, then I am arguing we must rethink our approach. We can no longer rely on state based groups of volunteers coming forth to arrange and conduct national conferences; the spirit may be willing but the time and the commitment of most are not.

For the 2014 Adelaide Conference the organising committee has retained the services of a professional convention organiser, SAPRO which has been a great help. However we are still attempting to do much of the detail work ourselves with SAPRO being largely acting as our secretariat. I submit this approach is becoming outmoded and unsustainable post 2014. I think convention organisers like SAPRO could do more of the heavy lifting for us, but we would have to accept that future profitability of conferences for ANTS shall likely be far less because more of the income will be consumed in overheads. Against this is the risk that we shall eventually be obliged to abandon national conferences for the simple reason we shall run out of willing volunteers to organise them. I am therefore suggesting the membership of ANTS consider alternative options for its national conferences after 2014. ANTS ought to be prepared to make much more use of

#### **ANTS SCHOLARSHIPS**

Scholarships are available to ANTS members to attend conferences and seminars which are relevant to the Society objectives with preference given to conferences with a strong nursing/midwifery education focus.

#### Criteria

Applicants are required to be current financial members for 24 consecutive calendar months prior and submit a paper identifying the expected benefits to the participant and the Society. Funding is available to the maximum of \$1000.

### Closing dates for applications:

- 31st January
- 31st July
- 30th April
- 31st October

#### ANTS RESEARCH GRANTS

ANTS wishes to encourage the initiation of research in all fields with a PRIMARY FOCUS of nurse/midwifery education practice by the provision of Seed Grants which may be utilised in a variety of ways, such as: Initial assistance with identification and definition of a research problem;

- The purchase of infrastructure to allow development of a research proposal;
- Payment of research assistants for initial data collection; and
- Funds to provide early access to statistical consultation

The level of funds available each year will be determined by the National Executive after analysis of the Society's current financial status and individual grants will not exceed \$2,000.00.

#### Criteria

Applicants are required to be current financial members of ANTS for 24 consecutive calendar months prior to their application.



professional convention organisers under the overall direction of a national program committee, drawing on member around the country and communicating primarily by electronic means.

As an example in support of this argument I think it would be feasible to use a convention organiser, in conjunction with a body like the Darwin Convention Centre, to mount a really good conference in Darwin in 2016. We could also consider holding a joint conference with another health association if we want to spread the workload and the costs. There is certainly no lack of interest by such bodies in visiting Darwin. Over the next 12 months something like nine health societies are conducting conferences in Darwin. The place is different, it has potential for related pre and post conference tours and it offers good facilities. It would be advisable to hold any such conference in July /August when the climate is at its most benign.

The venue for our 2016 conference can be decided in the next year yet regardless of where we elect to go, ANTS needs to recast its strategy in mounting future conferences after Adelaide or we shall likely cease having any conferences in the near future. This is an issue the member ship would be advised to address at our next Conference in 2014.

# **E-BULLETIN PEER REVIEWED SECTION**

#### **ABSTRACT AND KEYWORDS.**

An abstract of up to 250 words maximum should be included. The abstract should be informative and report on the key aspects of the publication and include the methodology and key findings of the paper. The abstract should not contain abbreviations or references. Up to five keywords can be provided.

#### **ACKNOWLEDGMENTS**

The acknowledgement of colleagues who are not named as authors should appear just before the reference list. The source of any funding or any potential conflict of interest should also be declared.

#### REFERENCES

The author is responsible for providing accurate references. Referencing must follow an Author-Date style, such as APA (American Psychological Association). The reference list must include details only of those works cited in the text, and all references cited in text must be listed.

## **SUBMISSION OF MANUSCRIPTS**

All manuscripts, and related correspondence should be submitted via email to the Peer Review Section Editor. The peer-review process will be managed by the Peer Review Section Editor. It is anticipated that authors will receive feedback or a decision on the manuscript within 6 weeks of submission.
