Nursing Education Forums

Nursing forums being undertaken with undefined outcomes at this stage, midwifery to follow at later date. Group representations are variable

- ENs under-represented
- Undergrads well represented
- VET sector – limited representation thus far

Chief Nurse Retirement

Deb Thoms retiring, with afternoon tea provided as a thankyou

NMBA UPDATE:

Endorsement for Prescribing

Consultation now completed and was well supported. Endorsement being finalised before processing with PBS.

- Designated RN prescriber – term to be used in future. May change to RN prescriber
- No supervision as inbuilt into post-graduate program. Post-endorsement with a period of mentorship required.

Consultations - refer to NMBNA website for links

- *Advanced Practice Consultation* - completed
- *Decision Making Framework* – open for consultation
- *Definition of Cultural Safety* – open for national consultation

New model for International N&M's

New model for internationally trained nurses and midwives to commence January 2020 and include an OSCE type examination process

ASQHA:

RTO Accreditation

Program to be accredited first by ANMAC for adding to scope and continue to maintain

Current review of RN standards

Continues from August 2017. Ongoing due to reducing from (9) to (5) standards

English Language requirement

Major change in requirements with a testing at beginning – not at the end. Outcomes have shown communication is an issue +++

Students

All nursing and midwifery students must be registered with N&MBA

Midwife Accreditation

Commencement of midwifery standards review with first consultation paper out now

EN Return to Practice

RTO's have requested a review of this standard to 'match RN re-entry standards'. About to be sent to NMBA for review.

AUSTRALIAN DIGITAL HEALTH AGENCY UPDATE:

Currently in CARE-TAKER mode

- My health-record summary of changes available at: www.myhealthrecord.gov.au/about/legislation-and-government/summary-privacy-protections
 - release to a third party is illegal without a judicial request
 - no archived or back-up copies kept. Must be 'destroyed' by law, if opt out
 - if opt back in a new record to be created
 - penalties for misuse – civil and criminal fines can apply
 - increased protection for victims of family and domestic violence incidents
 - based on Medicare – 90% of Australians have a MHR with 15,600 HCP engaged
 - over 14yo parents removed from access. Child to provide access approval
 - (4) pilot programs involved in partnering with community education/engagement
 - Next steps
 - secure messaging between providers
 - search directory
 - e-referrals
 - consistent and connected information
 - nurse champion program with diverse workplaces now concluded – issues identified were knowledge gaps and education needs

PRESENTATION BY DAVID LEE, NP – 'PBS 100 ISSUES':

Biomedical Prevention of HIV | Treatment as Prevention | Post Exposure Prophylaxis

- 50% of new diagnosis in Australia due to non-australian residence [ie students, refugees, visiting business people] with a barrier to diagnosis as non-access to medical care and/or unable to tell 'full story' to GP due to geographical location / age / privacy, ...
 - 90-90-90 HIV target treatments by 2020
 - 89% of people with HIV are aware of their status
 - 70-74% are GSM
 - 29% diagnosed late
 - HIV +ve person who has an undetectable viral load is not infectious (new finding)
 - 92% who access ARV treatment are estimated to have an undetectable viral load, therefore patient must remain engaged with treatments
 - Approx. 5% of effected suffers are not under any care, increasing risk to others
- Newer HIV antiviral regimes cause less side effects than previous treatments.
 - post exposure, currently a (28)-day medication course
 - S100's can't be prescribed by a NP; only by a MO.
 - currently 240 MOs (Sydney and Melbourne) have right to prescribe s100's
 - prescribing rights are subject successful completion of a further education

PRESENTATION BY KAREN BOOTH - AUSTRALIAN PRIMARY HEALTHCARE NURSES ASSOC.

Nurse Clinics in PHC are supported by funding from the federal government. Enhanced nurse clinics are replicable and exemplar clinics with a focus on chronic disease management and health ageing workshops.

Nurse clinics are the building blocks

APNA specific clinics currently available

- Bega teen clinic – greater access for mental and sexual health support
- Wound care clinic – Junction Place, Central Victoria
- Men’s health and well being clinic – Barwon Prison, Victoria

Next steps

When funding available include a (4)-year project : 35 nurses – 18 clinics at a cost of \$10,000/clinic seed funding

Inclusion of a Transition RN Program

(25) TPPP employed this round with 500 EOI’s received. Model to be expanded in the future

REVIEW OF NURSE EDUCATION 2019: A COMMENT

It was back in 2002 that the last independent review of nurse education was undertaken, called “Our duty of care”. A lot has happened in society and technology in the past 15 years, perhaps beyond the imagination of the reviewers in 2002. Facebook, Twitter and Instagram were not developed, so the impact of social media on health and education was beyond their scope. Also, I believe the nature and character of the student and their expectations around their nursing courses has changed. It is timely that there is another review. The federal Government is commissioning a review entitled “Educating the nurse of the future”.

Interestingly, when reading the review proposal, I do not think there is much of a focus on ‘future’, such as technology or the changing character of the student and social context, or an emphasis on quality of education or patient outcomes, but instead the focus is on work force. Perhaps this is not surprising since it is a Government initiative. The review aims to investigate issues around attracting more people into nursing, including international students. I think a review is needed, and it will be interesting to see what issues are raised in the reports submitted to the Review chairperson.

The terms of reference of the 2019 review are:

- the effectiveness of current educational preparation of and articulation between enrolled and registered nurses and nurse practitioners in meeting the needs of health service delivery
- factors that affect the choice of nursing as an occupation, including for men
- the role and appropriateness of transition to practice programs however named and
- the competitiveness and attractiveness of Australian nursing qualifications across international contexts.

The terms of reference for the 2002 review (Heath, 2002) were to examine the effectiveness of current arrangement for the education and training of nurses; factors in the labour market that affect the employment of nursing; and key factors governing demand and supply of education and training.

Ultimately, a review is only as good as the information it receives. You may be asked to be part of a team that submits a report, or submit your own report to the Review. It is important for you to have a voice so I encourage you to be part of this process and keep watching for media bulletins around your work place and online. The Australian Nurse Teachers’ Society will prepare a report for submitting to the review.

THE USE OF DIGITAL BADGES BY UNDERGRADUATE NURSING STUDENTS: A THREE-YEAR STUDY

ABSTRACT |

During a three-year study, 32% (n = 67) in 2015, 16% (n = 44) in 2016 and 55% (n = 161) of students in 2017 expressed an interest in using digital badges to enhance their learning. But who are these students?

This paper explores the features of students who are interested in using digital badges as a motivational reward to prepare for weekly face-to-face classes through engaging with online activities and resources. This paper uses a first-year undergraduate Bachelor of Nursing bioscience topic at an Australian university to report nursing students' interests around playing games, their digital badge history during the topic, and their self-reported attitudinal interest in using digital badges to enhance and personalise their learning.

Overall, the results indicate that some students chose to enhance their learning potential in class by earning digital badges prior to class. The results of this paper are relevant for nursing educators and educational designers seeking to integrate digital badges into motivational teaching practices, by evaluating the role digital badges play as a motivational game-based learning design element.
