#### Aim

## To gain insight into students' perceptions of Indigenous people

Determine if the course learning and teaching strategies implemented improved students' learning outcomes and attitude towards Indigenous people and Indigenous health in Australia.

#### Background

- Undergraduate nursing students require increased knowledge of health issues surrounding and impacting on Indigenous communities.
- This aspect of nursing education is particularly relevant
  - continuing health disparities in the Indigenous population
  - cultural and linguistic diversity of current and future student cohorts.

#### Background

The Bachelor of Nursing program at the University of Western Sydney has embedded Indigenous health into the undergraduate teaching program, with an expectation that students develop an awareness of Indigenous health and healthcare issues.

  - Pre and post survey

#### Pre results

- solve the second second
- ▲ 61.4% born overseas
- 23.7% were international students
- Average age 27.2 yrs.
- 1.4% Indigenous Australian
- Attitude towards Indigenous Australians
- Knowledge of Indigenous Australians

#### Post results

249 students completed both surveys

- Decrease in attitude towards Indigenous Australians (p=0.017)
- Marticipants'
  - Knowledge
  - intent to work with Indigenous Australians
  - confidence in caring for Indigenous peoples increased significantly at follow-up.

#### Comments

Understanding Indigenous history, culture and healthcare

"I had no real understanding or appreciation of their past injustices and the hardship they face today. I have discovered passion in myself to do what I can to help the Aboriginal people as a nurse and will be looking for work in this field once I am registered" (712).

Development of cultural competence

"I will be able to empathize with the patient and avoid misconceptions and discrimination in the giving of care" (101)

#### Comments

Enhance respect for Indigenous Australians' culture and traditional practices


"Because nursing is not just a profession that caring and helping others to have a better health but it is also a means of respecting and accepting others culture and beliefs"

Enhanced awareness of the inherent health and educational disadvantages for Indigenous Australians

"Huge impact because before this unit I did not have a good understanding of all the issues involved in the actual life of the Aboriginal people today" (357)
